
Referral Partnership Agreement With Hedge Invests International.

This Referral Partner Agreement (the “Agreement”) is a legal agreement between you (“Referral Partner”) and Hedge Invests International, a Crypto Investment Company, herein being collectively referred to as the “Parties.” BY SIGNING THIS “REFER A CLIENT” PARTNERSHIP FORM, YOU AGREE TO AND ARE BOUND BY THE TERMS AND CONDITIONS CONTAINED IN THIS AGREEMENT. THIS AGREEMENT INCLUDES THE TERMS AND CONDITIONS BELOW AND ANY DOCUMENTS OR MATERIALS REFERENCED HEREIN. This Agreement shall be effective as of the date of such form submission (“Effective Date”).

1. Purpose. Referral Partner may submit leads of Active Investors to Hedge Invests for the purpose of assisting Hedge Invests to grow in business. For the sake of clarity, any use of the term "partner" in this Agreement or in connection with the relationship created by this Agreement shall in no way imply that the Parties are engaged in a joint venture or that either Party otherwise has any ownership interest in, or common enterprise with, the other Party.

2. Qualification Process. Referral Partner shall submit leads to Hedge Invests for each Prospective End Investor by sharing his referral link to a party. Referral Partner shall complete all required fields as specified on such online form.


Hedge Invests shall notify Referral Partner, via email, if a lead has been “accepted” within two (2) business days of submission of the form.



3. Referral Fees and Payment. Hedge Invests shall pay to Referral Partner \$1000 for every three (3) active Investors referred. All payments shall be made into his Hedge Invests Account or any other provided bitcoin or other crypto wallets.


4. Unauthorized Representations; No Authority. Referral Partner shall refrain from making any representations, warranties or guarantees to Prospective End Investors or to the trade with respect to the specifications, features or capabilities of Hedge Invests' product offerings that are deceptive, misleading or otherwise inconsistent with the literature distributed by Hedge Invests or its suppliers with respect thereto. Referral Partner is not the agent of Hedge Invests and has no authority to execute contracts on Hedge Invests behalf. Referral Partner agrees to take all commercially reasonable steps to preserve and protect the goodwill and reputation of Hedge Invests. Referral Partner shall not engage in any conduct which may damage Hedge Invests' reputation. This Agreement is non-exclusive. The Parties understand and agree that Hedge Invests has the right to solicit Prospective End Investors directly and to appoint any number of additional representatives or agents to provide leads to Hedge Invests.

5. Representations and Warranties; Disclaimer. Each Party represents and warrants that in its performance of any obligations or services contemplated under this Agreement that such Party shall comply with all applicable laws, rules and regulations.



OTHER THAN THE FOREGOING, NEITHER PARTY MAKES ANY REPRESENTATIONS OR WARRANTIES TO THE OTHER PARTY OR TO ANY PERSON OR ENTITY WITH RESPECT TO THE OTHER PARTY'S PRODUCT OFFERING OR OTHERWISE, AND EACH PARTY HEREBY DISCLAIMS ALL IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, ACCURACY OF DATA, TITLE, NON-INFRINGEMENT, AND QUALITY OF SERVICE, AND IMPLIED WARRANTIES ARISING FROM COURSE OF DEALING OR COURSE OF PERFORMANCE. EXCEPT AS EXPRESSLY SET FORTH IN THIS AGREEMENT, Hedge Invests EXPRESSLY DISCLAIMS ANY REPRESENTATION OR WARRANTY REGARDING THE PERFORMANCE, FUNCTIONALITY, OR ANY OTHER ASPECT OF THE Hedge Invests PRODUCT OFFERING THAT Hedge Invests DEVELOPS OR PROVIDES HEREUNDER.

6. Term and Termination. The term of this Agreement shall begin on the Effective Date and shall continue until terminated in accordance with the terms of this Section 7. Either Party may terminate this Agreement for its convenience at any time by providing the other Party with fourteen (14) days advance written notice of termination. Sections 2, 3, 6, and 7 shall survive the termination of this Agreement. Any referrals received and accepted by Hedge Invests prior to the effective date of termination shall be honored and payment made pursuant to the terms of this Agreement.



7. Compliance. Referral Partner shall comply with the U.S. Foreign Corrupt Practices Act, the U.K. Bribery Act, and the anti-corruption laws of other countries, to the extent applicable. Referral Partner hereby represents and warrants that, in its performance under this Agreement Referral Partner has not, and will not at any time, directly or indirectly (through a subcontractor or other third party), pay, offer, give or promise to pay or give, or authorize the payment of, any monies or any other thing of value to influence the improper performance of any individual government officials and employees of state-owned enterprise. Referral Partner shall promptly inform Hedge Invests in writing upon becoming aware of any violations of laws in connection with this Agreement. Referral Partner hereby acknowledges and agrees that any violation by Referral Partner of this Section will constitute a material breach of this Agreement. In the event of such a violation, Hedge Invests will have the right to terminate this Agreement, without any liability whatsoever to Referral Partner, immediately upon providing written notice of termination to Referral Partner. Termination of this Agreement by Hedge Invests under this section shall be in addition to, and not in lieu of, Hedge Invests other legal rights and remedies
